To amend the Food for Peace Act to reform the food assistance programs under that Act, and for other purposes.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Food Aid Reform Act".

5 TITLE I—AMENDMENTS TO THE 6 FOOD FOR PEACE ACT

2	(a) IN GENERAL.—Title IV of the Food for Peace
3	Act is amended as follows:

7	United States"; and
8	(ii) by striking the second sentence;
9	and
10	(B) in paragraph (3)—
11	(i) by redesignating subparagraphs
12	(B) and (C) as subparagraphs (C) and
13	(D), respectively; and
14	(ii) by inserting after subparagraph
15	(A) the following new subparagraph:
16	"(B) the Committee on Foreign Relations
17	of the Senate;".
18	(2) In section $403(l)(1)(A)$ (7 U.S.C.
19	1733(l)(1)(A)), by striking "titles I and II" and in-
20	sert "title I".
21	(3) In section $404(c)(1)$ (7 U.S.C. $1734(c)(1)$),
22	by striking "eligible organizations" and all that fol-
23	lows through "under title II" and inserting "eligible
24	organizations may be made available under titles I
25	and III".

1	(4) In section 406(a) (7 U.S.C. 1736(a)), by in-
2	serting "may make available funds and" before
3	"may acquire".
4	(5) In section 407(c) (7 U.S.C. 1736a)—
5	(A) in paragraph (1), by striking subpara-

7	(B) in paragraph (4)(A), by striking "for
8	fiscal years 2001 through 2012"; and
9	(C) in paragraph (5)—
10	(i) in the heading, by striking "Non-
11	EMERGENCY OR MULTIYEAR" and inserting
12	"MULTIYEAR"; and
13	(ii) by striking "for ongoing non-
14	emergency or".
15	(6) In section 408 (7 U.S.C. 1736b), by strik-
16	ing "December 31, 2012" and inserting "September
17	30, 2018".
18	(b) RETROACTIVE EFFECTIVE DATE.—The amend-
19	ment made by paragraph (6) shall take effect as of De-
20	cember 31, 2012.
21	SEC. 104. EFFECTIVE DATE.
22	Except as otherwise provided in this title, the amend-
23	ments made by this title shall take effect on the date of
24	the enactment of this Act and shall apply with respect to
25	the provision of assistance under title II of the Food for

Peace Act (as so amended) beginning on the date that is
 180 days after such date of enactment.

4 SEC. 201. CARGO PREFERENCES.

5 (a) EXEMPTION.—Section 55313 of title 46, United
6 States Code, is amended—

7 (1) by striking "Sections 55304 and 55305 of
8 this title do not apply" and inserting the following:
9 "(a) IN GENERAL.—Sections 55304 and 55305 of
10 this title do not apply"; and

11 (2) by adding at the end the following:

12 "(b) ADDITIONAL EXEMPTED ACTIVITIES.—In addi-13 tion to the exemption under subsection (a) and notwith-14 standing any other provision of law, sections 55304 and 15 55305 of this title do not apply to activities carried out 16 under title II of the Food for Peace Act (7 U.S.C. 1721 17 et seq.).".

18 (b) CONFORMING AMENDMENT.—Section
19 55314(b)(1) of title 46, United States Code, is amended
20 by inserting ", except for activities carried out under title
21 II of that Act" before the semicolon.
