

Introduction:

Chairman Mast, ranking member Crow, and committee members; thank you for the opportunity to testify before you today. My name is Michael A. Cizmar, I am a former Infantry Captain in the United States Marine Corps, with multiple deployments overseas. I am also a retired Special Agent of the FBI with almost 30 years of working violent crimes and Special Weapons and Tactics, or (SWAT). After retiring from the FBI, I continued to serve my country for the Department of State (DOS) Diplomatic Security (DS), Antiterrorism Assistance Program in Afghanistan from 2013 to 2021.

I represent the non-profit organization **RAFIQ FRIENDS OF AGHANS, who, in working with our partners, comprise Project Exodus Relief**. RAFIQ founders are the U.S. Antiterrorism Assistance Mentors (ATA), comprised of former military, federal, state, and local law enforcement officers. We worked side by side our trusted and polygraphed Afghan Security Forces counterparts training and mentoring Afghan Law Enforcement personnel in support of the war on terror. These Afghan men and women came from the General Command of Special Police Units (GCPSU), and the Directorate of Public Safety (DPS), who fought the terrorist threats daily. Members from the GCPSU consisted of police commandos, or “Triples”, who were the first responders to any terrorist incident. These same people served as full time staff instructors at the Joint Afghan Training Center (JATC). There were fifty-four Instructors who were being paid a monthly stipend by the U.S. Department of State.

It is a part of my Marine and SWAT Team DNA to never leave **ANYONE BEHIND. (Pause)**

This pain, this stain **(Pause)**

on the honor of all the veterans who served their country faithfully during Operation Enduring Freedom never goes away, you just can't let it go... **(Pause)**

We have record of countless acts of hideous violence... **(Pause)** The execution of a pregnant Afghan National Police Officer in front of her husband; the beheading of two 12-year-old boys after the fall of Panjshir; the hanging of two members of the National Directorate of Security after they were granted amnesty, and the list goes on. Afghan Security Officers and their families now live day to day under the most severe conditions, with the Taliban actively hunting them, they lack the means and necessities to care for their families. If the Taliban doesn't imprison or kill them, a vast majority may die of exposure and starvation. And still hoping that America has not forgotten them. **(Pause)**

We shall never forget them, nor shall we give up the fight to bring these loyal allies to safety.

We have a much larger database of atrocities; we have compiled a chronological list of incidents perpetrated specifically against JATC personnel. The reports are firsthand witness or victim accounts, translated by these same people for submission.

From the fall to the present, Rafiq has had numerous incidents involving members and former students.

Noorgha Zadrán, aka Noor, and his brother Hayatullah were trained as basic snipers at JATC and were members of GCPSU CF 333 in Logar province. Hayatullah became a sniper Instructor Staff at JATC. Noor and his brother Hayatullah were exceptional marksman, and were known and, on the Taliban's, wanted list. Noor was denied a seat during the evacuation, but his brother Hayatullah was evacuated by the British.

On September 12, 2021, the Taliban found, then shot, and killed Noor in front of his family.

Shamsuddin Nazari, aka Shams, is a former member of DPS and was my senior sniper instructor at JATC. He was arrested by what we believed to be a rogue Taliban, in mid-September 2021, was subjected to beatings and torture, and after extorting what they could from him, released on September 23, 2021. In fear for his life, and that of his family, Shams packed them up and without documents, made a long multi leg escape into Pakistan, later to be evacuated to Spain.

On January 30, 2023, the Taliban located and arrested **Sayed Shah Saidi (SAYED-Shah SI-EEE)**, a former instructor of the JATC Counter Terrorism (CT), Training Section. Sayed Shah was interrogated and tortured for five weeks, at which time the Taliban agreed to release Saidi, extorting him of all he had in money and information.

In September 2023, **Ahmad Zubair Noori** a former member of the Presidential Protective Service (PPS), who we had assisted in getting to Pakistan but for economic reasons returned to Afghanistan, was located by the Taliban and hung in front of his wife and two young daughters.

On October 20, 2023, **Fawad Ehsan, Mohammad Hanif Andish, and Mohammad Islam Hasam**, all former member of JATC, were almost simultaneously arrested around Kabul by Department 07 (GDI). All three were held in dungeon like extreme cold environments, blind folded and subjected to extensive torture. Beatings included being struck in the legs with a metal pipe, punched, and kicked. On one occasion the Taliban utilized electricity to shock torture Fawad. **Islam** was released after four days, Andish and Fawad were held for five weeks. Fawad suffered a broken knee, and Andish a broken shoulder. To affect their release, all were extorted for money and any money the families could raise, cars, houses and in one instance a family friends' business.

It is my sincere hope and our prayer that after this committee hears of the atrocities being committed by the Taliban against our friends, there will be transformative change made to the current SIV requirements and allow a path to immigration for our Afghan Special Operations Counterparts.

Reason for Arrest by Taliban intelligence:

The military of the previous government / teacher and colleague of the American forces in Camp JATC

The Taliban had surrounded the location of the new Khairkhana project in the 11 district of Kabul, Afghanistan, in order to capture me on 30 January. I was at home, but I didn't go out, they didn't manage to get me out of the house, because they weren't sure that I was at home, from 29 January my phone was under following of the Taliban DGI from my phone there make sure that I am at home, they entered my house around 4:00 pm for my trouble. All the members of the family gathered together around the house and two of the guards to monitor them so that they would not have any kind of communication with me, and I stood on the snow in my underwear and bare feet until they thoroughly searched the entire house, even the neighbor's house, the items they took with them were computers, AR desk, CDs, related to military training, passports, and the search continued for about one and a half hours. Later, for the purpose of transferring my clothes, they asked me to leave my house and handcuffed me and transferred me to the supervision of Kapisa Provincial Intelligence Directorate. The investigation process started at 11:00 p.m., it was midnight, a person named Maulvi Hadi, the head of intelligence of Kapisa province, entered the prison with a number of people, they woke me up and started beating me. During the beating, I asked what my crime was, chief The intelligence told me that for 14 years you have been cooperating with American advisers and engaged in military training for anti-Taliban officers and he said that you should be killed, and the night ended like this.

Day o

A person named Maulvi Adel, the director of investigation, entered the jail with his colleagues to start, and the investigation began.

Charges have been filed

- 1 - Connecting with American consultants in the past and present
- 2 - Having information sources in Kapisa and Parwan province
- 3 - Providing information for the NRF force
- 4 - Collaborating with Hasht Sob newspaper

5 - Introduction of professors and former colleagues who have worked with American consultants

6 - Weapons and military equipment in hand

After the above accusations, five week of interrogation with various tortures such as sleeplessness, physical beatings, beatings with tools, plastic pipes, electric cables, sticks, electrocution, and keeping in a cold room and they also made my clothes stained with blood for mental torture and sending them to my family members.

In the course of the interrogations and beatings, I confirmed two of the above topics.

That I used to communicate with American consultants and currently there is no communication between us

I have weapons and military equipment, such as a weapon (m4), a Glock, equipment and a radio base

It is worth mentioning that after their research did not give results

And I had my own reasons, the head of intelligence Maulvi Abid Nam ordered to kill me. They handcuff my hands and put a black sack on my head and took me to an unknown place, and again after a few hours, they brought me to the same director's house with threats and ugly words.

Asking about weapons and equipment, I told them that they are available at home

They give me phone and told me to contact one of the family members who handed over the equipment to them

After completing the tasks, I found out that they were all trying

To be killed or to be imprisoned

But the day when I was transferred instead of unknown, with the efforts of some friends and relatives, who wanted to free me from the Taliban.

The Kapisa Taliban wanted to punish me without the knowledge of the Kabul Taliban.

Also, weapons and equipment were the reason why they didn't kill me

After a period of 5 weeks, I was released on bail and among the elders, but until now I am wanted by the intelligence of Kabul and Kapisa provinces.

Dear teacher hope you are fine. Last night Taleban killed this person in the Pagman district in the Kabul city. He was member of the PPS. His name was Zabahir . This news shocked everyone and caused a lot of concern in PPS groups.

Reason for Arrest by Taliban intelligence:

Since the collapse of Afghanistan in August 2021, we made an Afghan team along with our U.S. mentor Mr. Dean Barnhart to help and support our Afghan colleagues left behind in Afghanistan. We passed dark days and we put our lives in danger because of helping our colleagues. In last 29 months

We helped the following people:

Interpreters for Afghan allies.

Work for Afghan allies.

The mentioned allies worked shoulder to shoulder with U.S. mentorship and U.S. projects.

We provided safe houses in Kabul and Mazar for those who were in danger and displaced from the poverty of Afghanistan. We helped and supported the following U.S. Projects ATA Anti-Terrorism Assistance JATC Joint Afghan Training Center, Exodus, and MCF Afghan Employees.

We provided Pakistan visas and transport for Afghan allies who were in danger and had emergency needs.

We provided food packages for Afghan allies donated by their US advisors in Kabul, Herat, Parwan, and Mazar.

While we were busy helping our colleagues and the above-mentioned project workers. We were followed and recognized by the Taliban intelligence team and finally, the Taliban intelligence team arrested me and my two colleagues on Friday 20 October 2023, which was a very dark day in my life, They hid my eyes, covered my head with the cover they had and they handcuffed me and carried me in their car for more than 9 hours and finally, they took me to a cellar, removed my head cover but not the eye cover where the cellar was dark and very cold I spent three hours in this cellar then they took me to their prison which had 30 rooms so I spent 53 dark days alone in this prison room.

Arrested day.

Arrest day, when they arrested me they tortured me and hitboxes my face especially my left eye injured and my lips were bleeding but they did not care they took my laptop from the desk where it was in my living room, and they asked me about my smartphone, I gave them my wife's smartphone, which had nothing on it, so luckily they couldn't find my official smartphone, which had my emails and other documents related to my colleagues, family information sheets, Donation list, Safe houses fund reports, and other important docs what I sent to my U.S Mentorship. When they were taking me to their car my small son who is four years old was loudly crying to not take my father with you but they did not care at all they hid my eyes, covered my head handcuffed me, and took me to their car to the prison side.

The Taliban prison days.

On day one, they covered my eyes and handcuffed me, took me to their investigation room, turned on my laptop opened the safe House Excel sheet which was saved on my desktop, and asked me questions about the members of the safe house. I told them most of our safe house members moved to Pakistan and Iran countries, and then they asked me about the food package we provided the people received the food packages and asked about the location of their house I told them as they were my colleagues and they are jobless their immediate family who live at the U.S. they are ordered food package and we provided to them. Then they said we do our research if we find you lying or you working for the CIA, U.S. citizens, NRF, or any other group then we get our decision.

On the day fifth, they covered my eyes and handcuffed me, took me to their investigation room, where it looked like he was another investigator from the Taliban. He asked me all about safe houses and their location, food packages, and the locations we provided. I answered him that I only knew one safe house location who had already moved to Pakistan but the other safe house was not known to me Edris Panah as he rented the safe house he knows the other safe house location and he is in contact with safe house members and about the food packages I answered him that we never provided food packages through to their exact house we always provided food packages and transported their package on the main street on to their houses this is why I don't know about their houses.

On the day sixth, they covered my eyes and handcuffed me, took me to their investigation room, where it looked like he was another investigator from the Taliban. He asked me for my full name or any other name if I called for it. I told him my full name and I told him I have no other name mostly I am called Andish. He had a white paper and he wrote my full name and the date I was arrested by their team, He asked me how old I was, and I answered I was 38 years old then he said tell me everything about your education and your working background since you burn. I answered him all about my education of more than 30 years and my working background of more than 15 years for national and international organizations, then he mostly asked questions about my last job with DoS-ATA-JATC-LTE he was telling me why you worked for the U.S and other foreigner projects I answered him because of my education

field and because of my family feeding I worked with the U.S and other organizations. Then he said your JATC, Joint Afghan Training Center was one of the important centers that prevented our attacks against NATO and the Afghan Government otherwise we would have collapsed Afghanistan 10 years ago. I answered him that I never worked as a military officer anywhere I was just a local admin officer. I suggested to the investigator that it has been more than six days my family has no information about my situation and I don't know what happened to my family, father, mother, wife, and children so please call only one minute I want to talk with my family he said okay we will call but not now. Then they returned me to the prison room.

On the day 8th the prison commander with his two bodyguards and one laptop in his hand came into my prison room and played a video asked me what is this video for I told him this was not my computer and I had no idea about this video then he and his one bodyguard hits me kicks and asked again tell me what is this video I told him I have no idea about this video. Then he and his bodyguards did a very bad attitude and used bad words and turned their face to go I told him please I am very sick need medicines but they got out from my prison room without any response.

On the day 16th

They covered my eyes and handcuffed me, took me to their investigation room, where it looked like there were three investigators they started investigating differently than before. they asked me we have not searched your house completely so we take you to your house we are doing our search so it is your job to be very quiet don't talk with your family just show us everything you have like guns and all IT equipment. I answered them I had no guns; there was some IT equipment, but they were useless and not working. but the two investigators insulted and tortured me lots with police sticks, kicks, and boxes I asked them please I have five kids please I have no idea about the things you are looking for. they asked me some names of the guys we passed them food packages, the names of our safe house members, and our Local national Instructor names I told them I had no idea about all these names and please I was just a computer operator but again they tortured me with their kicks and boxes they said we know you were important person of this camp and you were reporting everything of this project to your mentors so tell us what is the CIA missions in Afghanistan I answered them please for sure this is the first time I hear CIA name form you guys but they said you are lying they tortured me more. I told them please my work backgrounds are civil works and it's totally computer work but they said we go to search your house and we know what to do.

On the day 17th.

It was 11:30 they covered my eyes and handcuffed me, took me to their Parking area. After 10 or 15 minutes they started their cars and moved me to my house side. On the way, they asked me to call my family and tell them now I was coming home so nobody was allowed to use phones when and how long we were there. I asked them its more than 17 days since I have not seen my children so when you take me to my house can I see and talk with my family they said you can see them where we are standing with you don't waste our time just see them all quickly and don't talk with them more just five minutes. When they closed my house they just opened my eyes but not the handcuffs I very much asked them if my children would be very scared if they saw this handcuff but they said no leave it be in your hands. They moved me to the fifth stair where my family was living. I saw more than 30 Talibs divided into each stair when we arrived on the fifth stair where my kids were waiting very happy to see their father but when they saw me with the handcuffs they were scared and started crying this time one of their commanders opened one handcuff and lucked both into my left hand. they got me into my house and started their searching they collected all and everything that belonged to my computer operating like two small photo sticky notes printers, an external hard drive, five PC internal hard drives, and Memories

of Cam Coder. My safe house security cameras recorded their moving onto the halls and the stairs I will share with you the pictures and they video for your information which are very heartening pictures and videos from the Taliban. their searching took more than 90 minutes so when they finished they took me back in this time my wife suggested to them that please my husband's clothes are very dirty give him two minutes I went to change his clothes they said okay just two minutes so in this time my wife closed the door and when I was changing my cloth my wife seen their tortured sign on my left shoulder she secretly took pictures of my left shoulder and after a quick cloth change they moved me back to their prison side. during moving me back to their prison side, I saw my mother at our safe house first stair she had missed me for the last 17 days when my mother saw me she cried in this time my mother felt down she fell unconscious because of the status I was facing. my local guard brought a cup of water for my mother but the Taliban did not care about it. When my mother became a little better from unconscious after drink water she told to Taliban that my son was working only because of feeding his children so why all these please release my son he is innocent. Taliban promised her that we go to release him tomorrow but all these promises were lies. They took me back to their prison in a lonely room.

On the day 19th.

As always to cover my eyes handcuffed me and took me to their investigation room. before asking any questions they tortured me a lot with kicks and boxes after all this they asked me why I formatted my hard drives there was nothing on my hard drive I told them they were very old and damaged and not working they brought my external hard drive which was secured with the password they asked me to enter it is the password I entered its password so luckily it was felt down by my children or maybe by themselves Taliban it was not working after entering password too. but again they got upset with me and hit me with a chair on my back body I said please this is not my mistake I hit the password so I don't know why this is not working. after all this they brought my colleague Ahmad Fawad Ehsan and investigated us together they said we recovered Fawad's computer and we found Paktia Sha-e-kot videos it seemed to us was a CIA mission. again Taliban asked what are the CIA missions in Afghanistan I said this video was sent to our mentor Mr. Dean Burnhart so we were working for our Mentor Dean Burnhart and we know Dean Burnhart was our Camp training advisor he just passed this video to Hollywood to collect some donations for our colleagues whom are jobless need at least have package. they said we want you guys to help us to find your colleagues especially those who still have contact with their advisors and those Local National Instructors not returned their M4, Glack, and their security gear I said as you guys arrested me they are no longer here they all escaped. They took me back to my lonely prison room.

On the day 23th

As always they covered my eyes and handcuffed me. they took me to their investigation room they brought my small phone and they said to call my family and tell them I would be released soon I called my wife and I told her with every hope that I would be released soon then my wife asked when but the investigator not confirmed its exact time he said soon then he said cut off your call. Then he asked me to call your brother if he helps us find a Local National Instructor this will release you. I called my brother and asked him if he knew any LNI locations he said just know our two LNI locations who are Edris Saraj and Rafiullah so they took my phone to get in contact with my brother if he helps them find the two mentioned LNIs' names. They returned me to my lonely prison room.

On the day 30th

They covered my eyes and handcuffed me. took me to their investigation room they said your brother is not able to find us the two LNIs' he named we going to release you call your brother now and ask him to

prepare the grant documents like the grant form, our two house original government documents and one supermarket government original document so called my brother and asked him to prepare the mentioned grant documents he said all these documents are available by tomorrow morning after all these granting documents Taliban said before releasing you we take you to your colleagues see if you helps us find one or more of your colleagues will be more benefits for you I told them I know one LNI location he is Colonel Abdul Qayoum Habibi. They returned me to my lonely prison room.

On the day 31st

They covered my eyes and handcuffed me they took me to Colonel Abdul Qayoum's location. when closed to his exact location they opened my eyes we searched all over there his location so luckily he was not over they said why you don't know where is his house I told them I just some time to transport him here not to his house but they said if you find you know his house but you not helping us to find him we will easily kill you in this time they hit me boxes inside their car. I told them please for sure I don't know his house I just know this was his location. They three times used U-turn and searched over there if he would be there so luckily he wasn't seen there. Then they returned me to my lonely prison room.

On the day 50th

They covered my eyes and handcuffed me. They took me to their investigation room they said we are in contact with your brother your grant documents are prepared by your brother we are going to release you but we want you to meet other members of our Afghan staff of the DoS-ATA-JATC Project or if I use the bad word against their Department or their government Emarat or if I would not be able to meet other members of our Afghan staff they said that they will return me to their jail. They said they could easily put in jail those who grant me and they have the grant original documents in their department. They returned me to my lonely prison room.

On the day 53rd.

They covered my eyes and handcuffed me. Took me to their investigation room. They filled out a release form then they recorded my video they wanted me to say which I said in the video that we were helping Afghan former security and Local staff by passing food packages, Safe houses, and Donations and filmed the Paktia Sha-e-kot Takor Ghar and sending the video and its fund report to my U.S Mentor.

As they were in contact with my brother one of their arresting team members who was a key person of the arresting team and was the one who moved me to my house on the day 17th I have his picture recorded by my safe house security camera I will share his picture for your information so he wants money from my brother so when he received %50 of the money from my brother then he released me. On the next day 12/Dec/2023, he received %100 of the money \$3000 from my brother.

Released Date 11/Dec/2023

Released Time 19:00

On the date 23/Dec/2023, my father wanted me to escape from Afghanistan and he said I did not care about what I passed my two houses and original documents and I would give the houses and the car which is a Toyota Corolla Model 2018 to the Taliban. He said all I want you to escape from Afghanistan and go to Pakistan. Then on 24/Dec/2023 I escaped from Afghanistan and moved to Pakistan. I am living in Pakistan now.

Now although, all Afghan refugees in Pakistan are facing the horror of forced displacement, our valid visas will expire in the next 30 days and I am very concerned about returning to Afghanistan.

However, I am still under the pressure of the dark days of Taliban prison, and still my parents, my brother and his family, and my friend who passed his supermarket's original license as a grant for the Taliban department. They all left behind in Kabul Afghanistan. As they are following and searching for me to meet other members of our Afghan staff of the Dos-ATA-JATC project.

My SIV case is transferred to Islamabad it is in the interview stage and my expedite is accepted. I am waiting for the SIV department here in Islamabad for an interview appointment.

Reason for Arrest by Taliban intelligence:

After the fall of the government on August 15, a group was organized in Signal for coordination and the process of transferring the Afghans. This group was supported and funded by Exodus and Rafiq, headed by American consultants. It had more than a hundred primary applicants, and almost 500 members. because of the leadership of the people, there was a large group of people in our leadership group, there were five members, one American, professor, Dean Phillip Barnhart was the team leader, and four Afghans.

The activities and tasks of the above team were as follows: coordinating the transfer of Afghans outside of Afghanistan, delivering Food Package to deserving families, counseling group members, distributing food packages, and preparing safe houses for former military personnel and civil society of several families who Having a green card, in coordination with the consultants, we transferred from Afghanistan to the United States, and we transferred several families to Pakistan and The SIV Member to USA, and a monthly amount of 100 US dollars per person in cash was provided by the consultants for the families of former soldiers and civil society who Being a member of the group, we used to distribute safe houses for more than 18 families. Every month, all their problems were solved by the above team. We did the same work continuously for more than two years. Five prominent members of our team were arrested by the Taliban one after another On October 28, at 11:20 in the morning, I was sitting in the food package distribution shop, when a person entered, asked for food items, but did not buy anything. Buy our home essentials here After a minute, four tall people entered the shop, their faces covered with handkerchiefs, they said that you are Muhammad Islam, I said yes, who are you? they said that we work for DGI and they said that your last name is Hasam, you are from Parwan Province, all the information about you I have to say later.

Take my mobiles and say, get out of the shop so that no one suspects, let's go in the car. We have a few questions for you We leave you again, when we got in the car, The told me that I understand everything about you

They told me that you distribute food packages to suspicious people

You have 15 safe house

You pay money for people

You are in contact with foreigners

He said again that Hanif Andish is your friend, I said yes, he said Fawad Bamiani is your friend, I said yes, he said Edris Panah is your friend, I said yes Where is Edris Panah? I told him that Edris Panah has been in Pakistan for a year. They threatened me and with ugly words, he told me to tell the truth, otherwise there will be problems for you. I said that I am telling the truth. He Said You're lying, we'll take you, the management here can't be investigated inside the car. Later, they put me down from one car and picked me up in another car. They told me that there were three people from the Taliban. They tied my eyes tightly. You are not allowed to move, The put my head down and tell you not to raise your head again, I will slap you.

Unfortunately, on the same day, my nephew named Fardin was also with me They also caught him apart from me the put in another room, they locked him up, and every four hours later, the asked repeated questions about how you are related to Muhammad Islam, do you help him in his work.

Fardin answered him, Mohammad Islam is my uncle, only today I came with him because we were buying for house food other days I was not with him.

The ware asked what was your uncle doing in the past, and he said that he was in the D10 officer who is the taxi driver at the moment. In addition to my other work, I used to drive a taxi with my personal car in order to earn enough money for my life and my family. The same questions have been asked repeatedly by Talabin, and my nephew Fardin has repeatedly given an answer to them.

The car was in motion for 45 minutes, after that it entered a mansion, they took me into a room where there was no one else, I think it was mostly a two-story repair, because on the second day, I was there for almost 5 hours, then again 4 people took me to the first place and asked me to start the investigation. My cell phones were turned on in front of them. Anyone who called me would turn on the loudspeaker and tell me who they were talking to. You do, no, they should understand that you are arrested by the intelligence. During the investigation, they told me who you are transferring the food packages to. I said that this is an online business. Anyone who applies, I will transfer them in exchange for money. I work in order to earn money and move on with my life. After my answer, they started beating me with punches and kicks. You work for foreigners, Westerners, and America.

During the investigation, I reasoned with them very regularly and answered many of their questions logically. They accused me of being a spy. I completely denied it. I said, "If you have any proof that shows that I am in contact with a foreigner, I am ready for any kind of punishment you give." I was ready. I was sure that the Taliban didn't have any kind of evidence from me, because I respected the immunity issues when communicating with foreigners, and the phone that belonged to the groups and I communicated with foreigners was separate, and I never carried it outside with me in a safe place. I kept it out of the reach of others.

I said to the Taliban, if you take me to any authority and authority, my words are the same, you have no proof, you have caught me because of business and to get money, and that's it. Court of justice, I said, my friend named Edris Panah is currently coordinating everything with foreigners in Pakistan. I am in

contact with him. When did you get them? They said, "We know for sure that you have 15 safe houses in Kabul. During this investigation, several of my friends and comrades call me they told me. Talk to them as if you were at home, not in the hands of the Taliban.

Because the Taliban were threatening me, another friend named Reza Roshan, who lived in house number 107, called me and asked me to pay the house rent.

I told him that I am at home and I will call you later. I hung up the phone. The Taliban beat me a lot, why didn't you talk properly?

The Taliban asked what position you are in. The Americans take you to America, while there are many other people who do not take them.

I said, "Why is it difficult to go to America? I am a former government soldier. I was in the training department of Watan Camp for ten years. For another four years, I worked in the administrative department of the headquarters of the D10 Presidency. I worked for one year as a plan manager for the D10 presidency. I have a bachelor's degree in law I know English and I know computers. I worked with American consultants for ten years. I have a case, but no progress has been made. I have not received a case number I have been waiting for years. We have been unemployed in Kabul. I am driving a taxi.

The Taliban asked where are the weapons and the government motor you had?

I said that I had left my weapon and car in the D10 presidency on the day of the fall of the government and I do not have anything of the government in front of me. You can ask the D10 officials of the presidency to be sure.

After this answer, I was beaten and tortured, and at the same time, my phone ranging

I saw that Reza is calling one of the Taliban say that he is the previous person, talk to him very easily and calmly

Reza said Bring the money for the house owner, because the owner of the house is fighting with me today. If we don't pay the rent, I told him that I am at my place and I will call you again.

The Taliban tortured me again. Who are you you paying the rent house for Reza's house? You must be in charge of safe houses. I said no, no, you are wrong. You know what a safe house is. You know the definition of a safe house for them. I defined safe. There is no safe house at all, but Reza is a very strange and unemployed person. From abroad, Reza's friend, who also becomes my friend, He Send rents their house to me out of humanitarianism, and I make it available to Reza because Reza cannot pay rent.

They said to ask for Reza to come in Kabul Airport square and pay the Rent for him

We want to see Reza how he is

I did not accept that they severely tortured and beat me

He said that Reza called and told him to come to Kabul airport Square and pay the Rent for him

Force me to do this

Reza called for the third time

I told Reza to come to the Kabul Airport Square and I will give you the rent . Within half an hour, Reza came to the Kabul airport Square, called me, and told me he is exact address. I went to and handed over the money to him.

Again, the Taliban put me in the car and closed my eyes and hands

I think that the other Taliban team was in the area and arrested Reza. I don't have information about what happened to Reza

We come back and Taliban told me Tell me about the food packages again

I said what should I say, he said how you get their money

I said that the site is a business, people apply and money is collected in the account

As much as the sales are, the money will be transferred to me

If this people who receive the food packages are from the ISIS group and are members of the resistance front

I said that I personally hate ISIS. It is not true. If it was ISIS or the resistance, prove it. I am ready to hang myself. Their friends send food parcels through the website and I prepare and deliver them for them in exchange for money. The Taliban said that without American content, you must be a spy. I said that I do such things. I think there are two reasons

1 My family and I went to go America.

2 Earning money to support my family for daily living.

After every question, they beat me, opened my phone, WhatsApp and email signal, and checked my phone memory.

Fortunately, they could not find any kind of evidence from my phone my phone was clear.

At the same time, another friend of me and our Team Member , Edris Panah, who was being searched for by the Taliban intelligence, sent a WhatsApp message on my phone and said

Islam, where are you?

The Taliban said, say, I am at home

I said so

Again, Edris Panah sent me a message to Hide himself as soon as possible, go to a safe place, because Fawad and Hanifa ndish were caught by the Taliban this morning. Later, from Edris Panah's messages, I knew that the situation was different. The Taliban had arrested all of us.

The Taliban put me under a lot of pressure. What are you doing to come up with such reports?

I said that Edris Panah is My old friend

I am currently in your custody

Edris Panah sent me a picture of the car and the Taliban who took Andish on WhatsApp. When I saw the pictures of the Taliban, they beat me up and said how Edris found our photo tell me how you received the photos.

Edris said that these photos were taken by brother Andish from the area when Andish was in trouble

They asked me again how many people and numbers are suspicious in your phone

The Taliban said call these numbers and chat with them

The first Number was Atiq

Atiq was a person who lived in one of our houses, 112. I paid the rent of Atiq's house monthly.

Call Atiq and where is he I call Atiq. I asked Atiq where you are.

He said I am home

I hung up the phone

Later, they came and told me to call Atiq and told Atiq to come in front of Shinuzadeh Hospital, where I used to hand over the house rent to him.

Atiq came in front of the hospital and the Taliban arrested Atiq

Then I called another number called Asif Degar and called another number called Sakhi Abdullah, that number was from my brother.

Later, the Taliban asked which department you were a professor for ten years and which departments you taught

I told them the protection department, the SD department, the advanced departments, the research department, they told me to show us your lectures, show us all the study materials, I said that I don't have any study materials, I lost them all when the government failed. Because of your fear, I set everything on fire and they beat me and harassed me.

They said again, you are a good person, you are a teacher, if we ask you to come and teach us, you will teach the Taliban

I said, "Unfortunately, I haven't had any teaching materials for 3 years, I haven't taught. It's very difficult for me to do such a thing."

Asking me how our Investigation was

I said I can't say anything

I knew they wanted to know if I really taught in the investigation department and if I knew anything

I told them that the investigation should be done in such a way that there should be no beating or torture

One person should be asking and one person note should note down the statements, but you are investigating with six people at the same time.

I said that in the investigation, one person asks questions and the second person remembers that 6 of you asked questions. It is very difficult for the suspect to answer the questions of 6 people at the same time.

In order to impress the suspect, organize the file and write its name on the back. In order to impress the suspect, I told them several methods of investigation.

Again Taliban ask who will pay you and how will you receive The money?

I told Edris Panah send it to me, and there is Corolla cars bring to me, sometimes money is transferred at the money exchange.

The Taliban said that our information shows that a huge amount of 20,000 dollars will come to you. I said no. One or two months later, the amount of 1,500 to 3,000 dollars will flow from which I will buy food packages and some amount will be paid for house rent.

After a period of three days and nights, on the third night, The release me as a guarantee.

Can you guarantee for us ?

I said what kind of guarantee?

the house Paper, the land, the flat

I said that I have no personal property

The Sayed that if you cannot guarantee, you will stay with us indefinitely and I will transfer you to another place, which is far more difficult than here.

I finally had to

A house that was left to us as an inheritance from my father, I give it to the Taliban as a guarantee. After three days and three nights had passed, on 09/30/2023, at ten o'clock at night, they brought me to my house in a car, and they took the house. They took me and told me to stay inside Afghanistan, not to make any kind of contact with foreigners, they took a written commitment and a video from me, emphasizing that if you do such things again, they will put you in jail and kill you, and they said that your phone numbers should be on and I am really tired, sick and mentally stressed, I don't know what to do now

This was the story of my predicament, I told it briefly.

Noorgha Zadran, aka Noor, and his brother Hayatullah were trained as basic snipers at JATC and were members of GCPSU CF 333 in Logar province. Hayatullah became a sniper Instructor Staff at JATC. Noor and his brother Hayatullah were exceptional marksman, and were known and, on the Taliban's, wanted list. Noor was denied a seat during the evacuation, but his brother Hayatullah was evacuated by the British.

Afghan sniper who worked with UK special forces 'was shot dead by the Taliban after being told there was no room for him and his family on RAF flight out of Kabul'

An Afghan sniper who worked with UK special forces 'was shot dead by the [Taliban](#) after being told there was no room for him and his family on RAF flight out of Kabul'. Noor, 29, had been a member of a British-trained Afghan unit known as CF333, but was not rescued in the airlift from Kabul airport that followed the Taliban takeover.

His brother Shakar Chi, 36, who also worked alongside UK special forces and made it to the UK, told the [The Times](#) that Noor had waited for days for a rescue flight out of Kabul but was eventually turned away as he didn't hold a UK passport.

Noor's brother Shakar, who uses a pseudonym, boarded a flight on August 27 and was promised by a member of the British army that Noor and his family would also be on a flight 'within 24 hours'.

However, the next day on August 28, the day the last evacuation flights departed from Kabul airport, Shakar spoke to his brother over the phone who revealed that he hadn't got a seat as there was 'no capacity'.

Shakar said that Noor told him that he had been 'kicked out' of the Baron hotel, which was being used by British diplomats and military to process those eligible to fly to the UK.

Noor said over the phone that a British soldier had said: 'There's so many people here with a red [British] passport. We can't take any more people on the flight. We don't have any capacity.'

'That's why they kicked me out,' he said.

Fifteen days later, Noor was traced to his sister's home on the edge of the Afghan capital Kabul and murdered by the Taliban.

He was shot three times in the chest and again as he lay on the ground by two gunmen.

Noor is said to have been shot dead while his wife and five children, all under the age of nine – the youngest just ten days old – were at the entrance of the house.

A Ministry Of Defence spokesperson said: 'We recognise the situation during Operation Pitting was incredibly difficult for all involved, and UK personnel worked in a fast-moving and complex situation to evacuate thousands of people in Kabul.'

The MOD added that they do not have a record of an application in this case, and it is understood that Noor did not officially apply to come to Britain under the government's Afghan Relocation and Assistance Policy (ARAP) scheme.

The murder prompted shock and anger from members of the British military, with former Colonel Ash Alexander-Cooper, OBE, a commander of specialist operations with the SAS, writing in a tweet: 'For those leaders still unsure, this is not a game, 'N' was executed by the Taliban in cold blood just a few hours ago. His crime? Years of loyal and professional service, mentored by British units.'

'There is no amnesty. Abandoned by us, this murder will not be the last.'

'This is the reality of the "new" Taliban,' Mr Alexander-Cooper said. 'Talk of inclusivity, diversity and amnesty is a joke and some are falling for it. Wake up.'

The murder was one in a series of revenge killings by the Taliban who have gone from house-to-house hunting those who worked with Western forces.

Dear Mike,

Below are the challenges when the Taliban arrested me.

I sold all my belongings and stayed at a friend's house for 3 days. At the same time, the Taliban came to my friend's house and arrested me. Then they moved me to an unknown place, and were going to kill me. At this time one of the Taliban asked me what do you have at home from your security job. I told him I have one Glock which is at home now, and then they decided to move me back to my home, and I passed them the Glock. The Taliban still searched all my house and found nothing, They were trying to take me back, but when my children started crying more they left me at me home, but they said they will come back.

After all these serious situations that happened in front of my family, this scared me, and my family was worried of what would happen to me, so I decided to go to a safe place, and I moved to my cousin's house, and I was there for four nights. At this time, my brother-in-law heard about the Taliban arrest that happened to me. He called me and promised me that he would try his best to get me a Spain Visa and he asked me to go to Pakistan as soon as I could, and in time I received a call from our previous house's local guard and he said that Taliban came back to find me on its next day and luckily I moved from there to my cousin house and as the situation was serious I rented a car and started going to Pakistan so we arrived in Spin Boldak.

We stayed at the border for 6 nights and we rented a room at the border hotel in this last 6 nights. But the border did not open. From there we moved to Kandahar. We arrived in the morning at 3 am. And there we stayed for 4 nights on the Nimroz province border again, in exchange for 250,000 Afghanis to take us to Quetta. On the way, we saw a lot of hardships and were scared for our safety. After 2 days in the desert and Pebble Mountains, we crossed one checkpoint on the way close to Quetta by paying 50,000 rupees to the police and finally, we arrived in Quetta Pakistan. We stayed in Quetta one night. Then I found a person. He said that in exchange for 70000 rupees, I would take you to Islamabad. On the way to Islamabad, we passed 10 police and the army. checkpoints. And 6 checkpoints were difficult. We rode in a truck until we crossed the one important checkpoint. And we were in the truck for 3 hours. And then we got in another car. And after 25 hours we reached Islamabad.

When we arrived at the hotel, we were asked for a passport. But we did not have a passport but by reference of my brother-in-law the hotel owner rented me a room. But unfortunately, as we arrived late it turned out that the plane, we were assigned to fly on flew 1 day ago, we spent a lot of time more than 11 days on the way to Pakistan which is why the Spanish flight flew and we have left behind again. Then we paid 3,000 rupees a day and 2,000 rupees for food. And we spent more than 55 days in this mentioned hotel till we got our Spanish Embassy interview appointment after the interview we took

more than 30 days then we received an email which was our Spanish visa and after 25 days we had our flight to Spain, so after all these last dark days and hard times finally we arrived in Spain.

Reason for Arrest by Taliban intelligence:

Since collapsing of Afghanistan in August 2021. We made a 4-person team along with our respected mentor Mr. Dean Barnhart. We put our life in Danger as you know working and helping these types of people in Afghanistan means working inside the fire.

Our team Member in Afghanistan:

Edris Panah

Mohammad Hanif Andish

Ahmad Fawad Ehsan

Mohammad Islam Hassam

We helped the following people:

US citizens who were citizen of united states and they were left behind in Afghanistan.

Green Card holders that were left behind in Afghanistan.

Interpreters and other direct US projects colleagues: people who worked with US forces and other projects were left behind we helped them to be evacuate from Afghanistan. Before they evacuate from Afghanistan and Pakistan, we distribute cash and food packages for them to feed their families and solve their problems.

Helping Previous Government employees who were in contact with their advisors and mentors: we helped Previous government workers and local national instructors who worked shoulder by shoulder with US forces and other training projects. We distribute cash and food packages for them to feed their families and solve their problems.

We provide safe houses for people who are in threat. We provided safe houses in Kabul and Mazar for MCF, Exodus, Operational Recovery and Rafiq-friend Groups members who were in threat on their living houses and areas.

We provided the Pakistan Visa and Transportation Facilities, for people who in emergency need.

We Distributed the food packages for the people who were need in Kabul, Herat and Mazar Province, during of the distribution many times we faced with problems, and it was about to be arrest by Taliban but change our way and change our vehicle every time.

During of these two years Taliban intelligence followed us and recognized us and on Friday morning 20 October 2023 acted and arrested all three of us from different locations (Ahmad Fawad Ehsan), Mohammad Hanif Andish and Islam Hassam, fortunately Edris panah was in Pakistan.

On October 20 – 2023 on Friday Mohammad Hanif Andish Call Me and Told Me I am Coming and Meet You I was Wait to Meet Him at 9:30 AM while I was buying bread with my 4-year son, four Taliban intelligence officer arrest me, they want me to leave my son on the street and go with them but I didn't leave my son on the street I took my son to home, TB DGI team went to my house and took my phones and my wife phone as well, while my wife was crying, they did not care about that. We left the house, and we moved to the known area, asking question start on the way to the prison, they hit my chest by box the guy who sit on my left side they covered my eyes until we arrived at the especial prison. All day they didn't give me anything to eat. It was at 8:30 pm one security guy brought food to eat. And said eat the food spy of Americans.

In the prison Week One:

Day one they took me to the investigation room while my eyes were covered, asking different questions regarding safe houses, my previous job and duty location. They ask me Why you helped Americans in the past and why you are working with them now you are spy of CIA and Americans forces. I told them majority of Afghans were working with foreign troops in Afghanistan not only me, but we also didn't work for CIA before collapsed and, we are not working with CIA. They stopped asking and hanged me opposite head down legs up for few hours, I have sob and cry, but they left me hanged and left the room. After two hour they come back and put me down. Start insulting me profession about what you do and show us the people who are in contact with Americans. You guys are spy of Americans and helped Americans who killed a lot of our Mujaheddin in the past. After that they took me back to the prison room where I was alone. I lost sleep I couldn't sleep all night; I was thinking about next day torturing.

Taliban Custody Day-2: while my eyes were covered, they took me to the investigation room. Asking questions about Mazar safe house, how many safe houses do you have in Mazar and How many spies are living there. I told them our safe houses closed last year in Mazar, and our guys who were in Maza\ r safe they were not spies and we were waiting for flights to go to Qatar, but unfortunately our flights got cancelled and all our guys left Mazar and come back to Kabul. They said what you answered that is not convincible for us. Slapped to face. Slapped and continued you lied you know more than this. Start slapping again till blood come from my right side of my noise. When blood come, they took me back to prison. It was terrible.

Taliban Custody Day 4: they took me again on the investigation room. There were different investigators although my eyes were covered, I recognized that they are not the same people. Start questions but this time there were different questions, you guys are distributing money for previous government employees and these guys are working for Americans and implementing US projects in Afghanistan to eliminate Taliban government, I told them that is not the case that you mentioned these money came

before only for families who were jobless, they didn't have job to feed their families, that was it, there were no any projects or programs. Again, they start torturing me, in this time they put the plastic on my head to nick squeeze and press the plastic to stop my breathing, I really lost my hope to see my family again my breathing stopped for few seconds they open plastic and start beating by pipe on my leg's knees and on my back part of my body. I cried and told them don't kill me I have family two son and my wife please forgive me. They said there is no forgive for you because you helped Americans and also you are helping them now as well.

In the prison Week Two:

On first day of second week again they took me to the investigation room before asking questions they insult and beat on my head. in this time their question was different. asking about CIA Programs and centers. Investigators said tell me about the CIA guys and their locations because you are helping them money food security and provide them safe houses. I told them we are helping people who are in need they are not working with CIA, they worked with Americans before collapsed but since collapsed they are jobless, and they are waiting to be evacuate from Afghanistan. They start torturing, one guy took my hands and another guy took my both legs and hit me on the wall although my eyes were covered, I cried and told them please forgive me, my right knee was broken because of the last week of torturing, they were insulting and said you guys must be kill because you are spy of Americans helping them, suddenly everything went black and I lost consciousness. When I waked up I was in the single prison room, and I checked my body my knee had very bad pain and even I wasn't able to move my right leg. There were no medicines to relief the pain.

Second week – Day 2: before asking questions, they tied me on the chair and start asking questions; investigator said tell me the truth otherwise you will be killed today. Can you tell me about people you distribute the food package and money? I told them we distribute the food for them on the public areas we don't deliver food package on their houses. They beat by pipes and kicking my body. The investigators left the dark room. Left me alone while I was tied on the chair and hand cuff was into my hands. That was terrible the investigation room was dark. I was not able to see even by hands. After 3-hour one person opened the room and took me to the prison.

Second Week- Day-3: asking questions about few names. I think these names are under their want: I don't remember all names only I remember one name: That is the name of (Pir Dill) as investigator said he was interpreter with Americans in one the camps in Kabul city. They said think about these names I told them I don't know these names.

In the prison Week Three:

Third week – Day-1:

They asked what else you guys to have done without food package, and money distribution and safe houses. It was my bad chance they recovered my phone and find out our paktia Shahi-e- kot mission. Last year we went shahi-e-kot to provide some pictures and videos for Mitch hill the guy who need for anaconda operation that took place on 4 March 2002, on this operation few American soldier has been

killed by Taliban and Al-Qaida members on the Shahi-e-Kot Mountain Takur Ghar. Investigator said which type of report you collected from Takur Ghar. First, I refused I said we went to paktia province for sightseeing when he showed the pictures of Takur Ghar. Why you are lying we know you go there.

I said it was only for a YouTube maker. Who paid for us money and we bring pictures and videos for him. Investigator said this is only one of that we find out. You guys did many of these types of activities in Afghanistan.

Third week- Day-2:

Question by investigator: who else was involved on the Shahi-e-kot Takur Ghar mission I said we were only four people. they said no. it was an important mission, and it wasn't for you Tube make it was one of CIA mission who needs information to collect from our Mujaheddin locations and strongholds. I said no that was not the case.

They lied down me on the center of room and start beating by the pipe. After the beating I was not able to stand and walk because in this time my kidney had pain along with knee and whole my body. I really lost my hope to be alive next day or not because their torture made thin my knee was broken. And my whole body tortured by pipe, kicking and slapping.

Third week – day-3:

Investigators take decision to search my house again in order to find more witnesses and documents about our works and contacting with our mentors.

It was 2:00 pm they open the prison where I was there, and one security guy said get ready we will go to your house for searching. They covered my head and open near to my area PD-17 area, it was first time I saw outside and brightness of sun since I was in the jail, on the other hand I was really serious to see my family because I was not sure to see my family again in the future or not. We arrived at 4:00 pm at my house they make a security perimeter. And enter to my house start searching. they search each and everything in my house. They find only my computer; they couldn't find anything else we left the house and come back to the jail.

In the prison Week Four:

Fourth week- Day-1: last week investigator took my computer password during of the weekend they opened my computer and searched and recovered it, they find only few pictures from my work area. and the other files were from my personal and university lectures there were some family pictures. Investigator said these are not the documents that we need them. Give me CIA members and the list of money and food package distribution we need them. I told them we don't have any connection with CIA. and I don't have list of distribution, as soon as we receive the food package order we delete the personal information of the people, because we don't need to keep other people personal information. In this

time their torture were really dangers they tortured by electric. I have distance from the dead only few seconds God saved me. I Cried and apologized please don't kill me I have two kids they are small.

After all that torturing my body find tremble and fever. It was horrible I lost sleep my knee had very bad pain even I was not able to go to the rest room.

In the prison: Week Five:

They conclude all the questions on week five:

Do you know who has weapon among of the people you are helping them. From the camp instructors and from other groups. Give me the list and show me he locations.

I answered and convinced them that I don't know who have weapon on their houses.

Again beat by pipe. Beating by pipe was my daily torture.

They want me to give list of the people who got weapons from the JATC camp trainings. I told them I don't have the list because everything eliminated before collapsed by Americans in the camp.

Investigation and Torturing continued till week 6, on week 7. On week 7 they were in contact with my brother in order to see one of their informants. They want money from my brother. My brother borrowed money and gave to the informant.

Before releasing us from prison they took videos from us, on this video they want us to tell them that we were helping Americans in the past and we are helping them now as well. If anytime we want you to come, you should come and answer our questions.

And also, they want from us to say on the video the activities which we did during of these two years are like spying and against Taliban. They kept this video with them. It means we are in the jail because Taliban are tracking my phone numbers and they know our residential are and they took sponsorships kept some documents including my computer with them:

My Vehicle document.

My brother friend business license

My computer

Anytime if they want me, they will easily find me. their intelligence team are following me.
